

Diploma of Mental Health CHC53315



This qualification covers workers who provide a range of community services focusing on:

- Rehabilitation and support for people affected by mental illness and psychiatric disability.
- Implementing community based activities focusing on mental health, mental illness and psychiatric disability, and
- Mental health promotion work.

This qualification reflects the role of workers who provide services to clients in relation to mental health issues. They can provide counselling, referral, advocacy and education/health promotion services. These workers are required to have high level specialist knowledge, skills and competencies especially in regard to laws affecting people with mental health issues, the range of services available to them and health issues related to mental health.

COURSE REQUIREMENTS:

DOMESTIC STUDENTS

Training and assessments are conducted in English. A pre training intake interview will be conducted and each learner will undertake a Language, Literacy and Numeracy Assessment.

There are no pre-requisites or any other training package entry requirement to enrol in this course.

- must have a PTE Academic score of 50 or
- must have a Cambridge English Advanced (CAE) score of 52 or
- must have an OET score of pass
- Must be 18 Years or older
- Completed Australian year 12 or equivalent

Classroom delivery: Face to face training and Practical Placement.
